TOLD DIA COL. PARKER THE
RPF IS ATTACKING SOUTH THROUGH THE DMZ. THEY EXPECT TO
BE IN XIGALI TOMORROW. THE RPF JUSTIFIED THE MOVE
BECAUSE THE CEASEFIRE HAS BEEN VIOLATED. ITS XIGALI
CONTINGENT HAD BEEN ATTACKED. THE RVANDAN ARMY IS
KILLING OFFICIALS AND TUTSIS, AND THE UN IS UNABLE TO
CONTROL THE SITUATION. THE RPF VILL NOT INTERFERE WITH
EXPATRIATE DEPARTURES AND VILL COOPERATE WITH UNAMIR AND
FOREIGN GOVERNMENTS IN KIGALI. (1415 EDT KAGAME/PARKER

2. (LOU) MAJOR GENERAL NDINDILIYIMANA HAS TAKEN CONTROL OF THE ARMED FORCES AND IS NEGOTIATING WITH UNAMIR GENERAL DALLAIRE AND RPF ELEMENTS AT AN UNDISCLOSED LOCATION. ACCORDING TO THE EMBASSY, THE MAJOR GENERAL IS "PROFESSIONAL" AND WANTS AN END TO THE FIGHTING. (EMBASSY TELCON)
