MEMORANDUM FOR THE RECORD

SUBJECT: Luncheon Meeting with [ ] at Rive Gauche  
 [ ] 1960.

1. I brought up the subject of EICHMANN and told [ ] that we had uncovered some very interesting documents on EICHMANN'S activities which, I felt sure, would be of interest to [ ] and [ ] said that he had received a letter from [ ] instructing him to tell [ ] that EICHMANN'S capture had been a combined [ ] operation [ ] the [ ] was all smiles and receiving all around congratulations. He then asked me if I had seen an article in the New York Herald Tribune which was the result of their correspondents interview with a tall greying man and a short black-haired man [ ] and [ ] whose names the correspondent could not divulge. The article summarizes the organization of the Israeli services. I admitted that I had not seen it and [ ] agreed to give me the date of the paper. [ ] then expressed the opinion that he personally thought it was wrong to make a big case of EICHMANN; that they would, in such an event, be using their precious assets which would be better spent on the present-day enemy-- the Communists. He stated that much divided opinion exists among both Jews and Gentiles; and cited Dr. Israel GOLDSTEIN who came out against it because in the process so much dirt would be dug up that it might even generate more anti-semitism. [ ] mentioned that BEN-GURION had just received a telegram from ROCKWELL, the Virginia anti-semitic who denounced him for the illegal capture of EICHMANN and said that he was now free to pursue his anti-semitic efforts. [ ] wondered if we had anything on this latest episode.
