2. AMBASSADOR CALLED ON DOCTOR SUAZO AT 11:30 LOCAL TIME SEPTEMBER 27 TO DELIVER TEXT OF PRESIDENT REAGAN'S LETTER ON CONTADORA. SUAZO READ THE LETTER ALOUD IN AMBASSADOR'S PRESENCE AND NODDED IN AGREEMENT WITH EVERY PHRASE. HE WAS VERY APPRECIATIVE. AMBASSADOR INFORMED SUAZO THAT WE WOULD BE CONVEYING TEXT TO PAZ BARNICA IN SAN JOSE.

3. SUAZO TOOK OCCASION TO EXPRESS CONCERN ABOUT GUATEMALA'S POSITION ON CONTADORA AND CONCERN THAT IT MAY HAVE CUT A DEAL WITH MEXICO AND NICARAGUA. IN RESPONSE, AMBASSADOR NOTED VARIOUS INITIATIVES WHICH HAD BEEN UNDERTAKEN TO HARMONIZE POSITIONS WITH GUATEMALANS, INCLUDING PRESIDENT DUARTE'S SEPTEMBER 26 VISIT THERE. NEGROPONTE
