2. UNDERSTAND FROM CRAIG JOENSTONE THAT YOUR ETA MAY HAVE SLIPPED SLIGHTLY. CRAIG EXPRESSED DOUBTS TO ME THAT ARA SHUFFLE WOULD TAKE PLACE BEFCRE MAY ONE.
3. I CABLE YOU ON THIS NOW BECAUSE I HAVE SOME PLANNING TO DO WITE RESPECT TO RECUPERATING MY HOUSE IN WASHINGTON AND, REGRETTABLY, EVICTING MY VERY NICE TENANTS. IN THIS CONNECTION, I WOULD LIKE NEXT WEEK TO ADVISE THEM THAT MY LIKELY WASHINGTON ETA (DIRECT FROM TEGUCIGALPA) WILL BE MAY ONE, LEAVING HERE ON SAME DAY. I HAD EARLIER ADVISED TENANTS OF LIKELY RETURN INEARLY APRIL AND SLIPPING THE DATES A BIT WILL RELIEVE THE PRESSURE ON THEM TO FIND ALTERNATE, TEMPORARY HOUSING.

I RECOGNIZE THAT THERE ARE MANY FACTORS BEYOND OUR CONTROL IN ALL OF THIS BUT WOULD WELCOME ANY REACTION YCU HAVE TO MY PROPCSED COURSE OF ACTION OUTLINED PARA THREE ABOVE IN LIGHT OF YOUR OWN SITUATION. I HAVE TODAY, INCIDENTALLY, RECEIVED WORD OF WHITE HOUSE APPROVAL OF MY ASSISTANT SECRETARYSHIP AND WILL START THE PAPERWORK AS SOON AS I GET IT.
