Dear Ms. Noonan:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, et seq., I hereby request copies of all documents in the custody or control of the Federal Aviation Administration (FAA) as described below. As we discussed by telephone today, some of these documents may be in the possession of the Department of Transportation (DOT). Because the DOT referred me to the FAA, you advised me to send a single request to you. Thank you for your assistance.

The documents I would like copies of are as follows:

- (1) All documents relating to EgyptAir's status and authorization as a foreign air carrier, including all documents submitted by EgyptAir pursuant to 14 C.F.R. Part 211, all documents relating to or containing the information described in the Department of Transportation's "Foreign Air Carrier Information Packet," all related correspondence from or to EgyptAir, and all related correspondence from or to EgyptAir's insurance carriers, including MISR Insurance.

- (2) All documents relating to the provision of aircraft liability insurance covering EgyptAir's U.S. operations, including all related correspondence to or from EgyptAir relating to such insurance, and all correspondence to or from EgyptAir's liability insurance carrier(s), including MISR Insurance.
- (3) Copies of all bilateral aviation agreements between the United States and Egypt, amendments or modifications to such agreements, and copies of all correspondence relating to such agreements and amendments.
- (4) Copies of all documents submitted by EgyptAir pursuant to the Foreign Air Carrier Family Support Act; 49 U.S.C. § 41313, including the "resource plan" required by the Act.
- (5) Copies of all documents relating to any subsidy by the United States to support EgyptAir's operations.

I believe that all of the foregoing information is properly discoverable under the Freedom of Information Act. If any portion of the information is deemed exempt from discovery, please provide me with a detailed statement of the reasons for each exemption and an index or similar statement describing the nature of the documents and things withheld. Pursuant to the amended Act, I further request that if some portion of the file is deemed exempt, you forward me a copy of the reasonably segregable portions of the file in question.
