II. FACTIONAL ACTIVITIES.

A. POLITICAL BROAD BASED TRANSITIONAL GOVERNMENT NOT YET INSTALLED. NEGOTIATIONS ONSOING, SRSG HAD A MEETING WITH SEVERAL AMBASEADORS.

B. MILITARY.

- (1) ROF: CARRIED OUT FIRING PRACTICE AT CANOMBE ON 14 JAN 94.
- (2) RPF, RPF CHAIRMAN HOLD A PRESS CONFERENCE ON 141730 JAN 94 AT CND BUILDING.
