18. WE RECOMMEND USG CONSIDER MAKING A SECOND CONTRIBUTION TO UNHCR FOR BURUNDI REFUGEES AS OUR FIRST CONTRIBUTION OF USD 5 MILLION WAS AGAINST THE FIRST 3-MONTH APPEAL. THE BURUNDI REFUGEES WILL NEED FOOD ASSISTANCE AT LEAST UNTIL THE NEXT HARVEST (JUNE) WHETHER THEY ARE IN NEIGHBORING COUNTRIES OR BURUNDI. THEY WILL NEED REINSTALLATION ASSISTANCE IF THEY REPATRIATE. RMA/GENEVA WILL WANT TO CONSULT HCR HADQUARTERS ON THE ACTUAL STATUS OF CONTRIBUTIONS TO APPEAL RUNNING THROUGH APRIL 30 AND DIRECTION OF PLANS FOR NEW APPEAL.
