1. CONFIDENTIAL - ENTIRE TEXT.
2. SUMMARY. THE GOVERNMENT OF RWANDA (GOR) AND THE RWANDAN PATRIOTIC FRONT (RPF) ARE LIKELY TO FIND COMMON GROUND ON REFUGEE REPATRIATION IN DISCUSSIONS SCHEDULED FOR DECEMBER 14-20 IN ARUSHA WITHIN THE FRAMEWORK OF THE ARUSHA PEACE TALKS. THE MINISTER RESPONSIBLE FOR REFUGEE AFFAIRS TOLD THE EMBASSY THE GOR WILL BE OPEN TO RPF CONCERNS AND WILL AVOID

UNCLASSIFIED

GIVING ANY APPEARANCE OF COMPROMISING ITS COMMITMENT TO THE RIGHT TO REFUGEE RETURN.

3. AT ARUSHA THE GOR WILL NOT/NOT INSIST ON THE REFUGEE OPTION OF NATURALIZATION IN COUNTRIES OF ASYLUM. IT PLANS TO LAY THE GROUNDWORK FOR BILATERAL AGREEMENTS ON REPATRIATION WITH COUNTRIES OF ASYLUM AND WILL SEEK DONOR SUPPORT FOR ACCELERATING THE PACE OF IMPLEMENTATION OF A PARTIAL PLAN OF ACTION FOR REFUGEE RETURN. BY DELINKING NATURALIZATION FROM THE OTHER TWO REFUGEE OPTIONS INCLUDED IN THE 1991 DAR ES SALAAM DECLARATION AND BY PUSHING TOWARD EARLY IMPLEMENTATION OF THE REPATRIATION OPTION, RWANDA MAY OFFER THE BREAKTHROUGH NEEDED TO REINVIGORATE THE PROCESS FOR A REGIONAL SOLUTION TO THE RWANDAN REFUGEE PROBLEM. SEE PARA 18 FOR SUGGESTIONS FOR THE USG OBSERVER AT THE ARUSHA TALKS. END SUMMARY.

5. THE MINISTER OF LABOR AND SOCIAL AFFAIRS, LAMDOUALD NDASINGWA, OUTLINED TO DCM THE STRATEGY THE GOR PLANS TO ADOPT AT THE ARUSHA TALKS ON REFUGEES, TARGETED FOR DECEMBER 12-20. THIS STRATEGY, APPROVED AT THE WEEKEND BY THE MULTI-PARTY COUNCIL OF MINISTERS, HAS AS ITS CENTRAL FEATURE OPENESS. THE GOVERNMENT DELEGATION INTENDS TO BE FLEXIBLE AND RESPONSIVE TO THE RPF DEMANDS. IT WILL TAKE THE POSITION THAT THERE ARE NO INSURMOUNTABLE OBSTACLES TO THE RETURN OF ALL REFUGEES WHO WISH TO RETURN. IT WILL ALSO AVOID APPEARING TO COMPROMISE THE GOR'S STATED COMMITMENT TO THE RIGHT OF REFUGEE RETURN.

6. IN A SIGNIFICANT POLICY DEVELOPMENT, THE MINISTER SAID THE GOR WILL NOT/NOT INSIST ON THE NATURALIZATION OPTION FOR THE REFUGEES IN NEIGHBORING COUNTRIES. IT WILL INSTEAD CONCENTRATE ITS ATTENTION ON REPATRIATION AND ON THE LOCAL SETTLEMENT OF REFUGEES WHO OPT TO HAVE RWANDAN PASSPORTS BUT STAY IN COUNTRIES OF ASYLUM. THE MINISTER SAID THAT THE RPF VIEWS GOR EFFORTS TO ASSURE THE NATURALIZATION OPTION AS A WAY OF SIDE-STEPPING ITS COMMITMENT TO THE RIGHT OF RETURN. HE ALSO NOTED THAT IT IS A POLITICALLY SENSITIVE ISSUE IN THE NEIGHBORING

COUNTRIES. THUS, HE SAID, THE GOR WILL AVOID RAISING THIS OPTION AND TAKE THE POSITION THAT THE DESIRE FOR NATURALIZATION IS THE PERSONAL MATTER FOR A REFUGEE.

7. IN RESPONSE TO DCM'S QUERY, THE MINISTER SAID THAT THE GOR WOULD WELCOME PRESSURE FROM OTHER QUARTERS TO ENCOURAGE NEIGHBORING COUNTRIES TO LIVE UP TO THEIR

MODIFICATIONS BY THE COUNCIL OF MINISTERS.

-- POOL OF RETURNEES. THE GOR ACCEPTS THAT THE POTENTIAL POOL OF RETURNEES IS LARGER THAN THE NUMBER OF PERSONS REGISTERED AS REFUGEES WITH UNHCR. WHERE DIFFERENCES DEVELOP BETWEEN THE GOR AND THE RPF ON THE COMPOSITION OF THIS POOL, THE GOR WILL SUGGEST DEFERRING TO INTERNATIONAL NORMS.

-- ORDERLY RETURN. THE GOR WANTS REPATRIATION TO BE ORGANIZED AND UNDER THE AUSPICES OF UNHCR RATHER THAN SPONTANEOUS. RETURNEES WILL HAVE THE OPTION OF RETURNING TO THEIR FAMILIES OF ORIGIN, TAKING UP NON-AGRICULTURAL PROFESSIONAL ACTIVITIES, OR SETTLING IN IDENTIFIED RURAL AREAS.

-- TIME-TABLE. THE GOR OFFERS NO FIXED TIMETABLE FOR THE RETURN, THOUGH IT WILL ENDORSE THE PRINCIPLE THAT RETURN SHOULD BEGIN AS SOON AS POSSIBLE.

-- REFUGEE PROPERTY CLAIMS. THE COUNCIL OF MINISTERS REJECTED A PROPOSED 10-YEAR LIMIT ON

REFUGEE PROPERTY CLAIMS. IT OPTED INSTEAD TO ALLOW ANY CLAIMS, THOUGH DISTINCTIONS ARE LIKELY TO BE MADE BETWEEN RURAL AND URBAN CLAIMS BECAUSE OF DIFFERENT "OWNERSHIP" MODES, AND FINANCIAL SETTLEMENTS WILL HAVE TO BE WORKED OUT. THE MINISTRY'S REFUGEE DIRECTOR WILL BE PURSUING THIS QUESTION FURTHER PRIOR TO THE DISCUSSIONS.

-- REINSTALLATION. THE GOR ACCEPTS THE PRINCIPLE OF

REFUGEE ENTRY INTO THE CIVIL SERVICE AND TO ADJUSTING LAWS TO MAKE IT POSSIBLE. HOWEVER, THE MINISTER POINTED OUT THAT THE COUNTRY'S STRUCTURAL ADJUSTMENT PROGRAM PRECLUDES ENLARGING THE CIVIL SERVICE.

8. THE GOR'S APPROACH TO THE MODALITIES OF REPATRIATION AND REINTEGRATION APPEAR TO GO A LONG WAY TOWARD MEETING CONCERNS EXPRESSED BY THE RPF IN ITS PRELIMINARY WORKING DOCUMENT. THE RPF DOCUMENT, PREPARED FOR THE GOR AND THE UNHCR FOR THE NEXT ROUND OF TALKS (AND PROVIDED TO THE DCM BY UNHCR), HIGHLIGHTS FOUR PRINCIPLE ISSUES FOR DISCUSSION: COMPOSITION OF THE REFUGEE POPULATION, TIMING OF RETURN, REFUGEE PROPERTY CLAIMS, AND REINTEGRATION MODALITIES. ACCORDING THE UNHCR, THE LATEST DOCUMENT REFLECTS A MORE FLEXIBLE APPROACH ON THE PART OF THE RPF.

9. IN ITS DOCUMENT, THE RPF DEFINES THE POOL OF POTENTIAL RETURNEES AS ENCOMPASSING NOT ONLY REFUGEES REGISTERED WITH UNHCR BUT ALSO SELF-SETTLED EXILES AS WELL AS THEIR CHILDREN. THE RPF ACCEPTS PHASED RETURN OVER AN UNSPECIFIED PERIOD, IN A WAY THAT WILL PERMIT SUFFICIENT TIME FOR PREPARATION AND NOT DISTURB EITHER THE COUNTRY OF ASYLUM OR THE COUNTRY OF RETURN. AS A HUMANE SOLUTION TO THE QUESTION OF REFUGEE PROPERTY, THE RPF SUGGESTS RWANDA SET ASIDE UNOCCUPIED AREAS OF LAND ON WHICH TO RESETTLE RETURNEES. TO FACILITATE INTEGRATION, THE RPF SEEKS

ROLE OF OBSERVERS AT ARUSHA

11. A MEMBER OF THE GOR NEGOTIATING TEAM TOLD THE DCM THAT THE OBSERVERS AT ARUSHA, WHO HAVE BEEN INVITED TO "PARTICIPATE AS OBSERVERS" IN THE REFUGEE DISCUSSIONS, ARE EXPECTED TO PLAY AN ACTIVE ROLE. THE MINISTER SAID THAT THE GOR WILL ATTEMPT TO ENGAGE THE NEIGHBORING COUNTRIES IN THE DISCUSSIONS ON THE MODALITIES OF REPATRIATION AND LOCAL SETTLEMENT. HE INTENDS FOR THE DISCUSSION TO LAY THE GROUNDWORK FOR FOLLOW-ON TALKS LEADING TO BILATERAL AGREEMENTS. THESE AGREEMENTS WOULD PROVIDE THE FRAMEWORK FOR A REPATRIATION OPERATION.

12. THE MINISTER SAID THAT HE HOPES THE DONOR COUNTRIES PRESENT AT ARUSHA WILL PUSH THE OAU AND UNHCR TO ACCELERATE IMPLEMENTATION OF A PARTIAL PLAN OF ACTION FOR REFUGEE RETURN. BY THIS HE MEANS THAT THE GOR WANTS TO MOVE FORWARD WITH REPATRIATION AND LOCAL SETTLEMENT, EVEN THOUGH THE THIRD OPTION CALLED FOR IN THE DAR DECLARATION, I.E., NATURALIZATION, MAY NOT YET BE VIABLE. THE MINISTER SAID HE HOPES DONORS WILL ALSO MAKE A MORAL COMMITMENT AT ARUSHA TO PROVIDE FINANCIAL ASSISTANCE TO THE REPATRIATION OPERATION. HE ASKED SPECIFICALLY ABOUT THE POSSIBILITY OF A FUND BEING CREATED IN ADVANCE OF REPATRIATION THAT RWANDA COULD DRAW FROM TO DEVELOP THE INFRASTRUCTURE NEEDED TO PREPARE RESETTLEMENT SITES. HE NOTED THAT UNHCR PLANS TO HAVE A TEAM IN RWANDA IN JANUARY TO CONDUCT SOCIO-ECONOMIC STUDIES LINKED TO REFUGEE INTEGRATION.

13. THE UNHCR REPRESENTATIVE IN KIGALI TOLD THE DCM THAT HE HAS URGED HIS GENEVA HEADQUARTERS TO VIEW THE ARUSHA TALKS NOT ONLY AS A FORUM FOR DISCUSSING THE MODALITIES OF REPATRIATION BUT ALSO FOR HIGHLIGHTING THE ROLE THE COUNTRIES OF ASYLUM MUST PLAY IN REALIZING A DURABLE SOLUTION. HE BELIEVES ARUSHA CAN BE A FORUM FOR DISCUSSING HOW THE PARTIES TO THE DAR DECLARATION WILL TRANSLATE THOSE COMMITMENTS INTO CONCRETE ACTION. HE HAS ALSO URGED GENEVA TO EMPHASIZE THE IMPORTANCE OF INTERNAL SECURITY AS A PRECONDITION FOR ASSURING REFUGEES CAN RETURN IN SAFETY AND DIGNITY. THE KIGALI REPRESENTATIVE ALSO BELIEVES THAT REFUGEE RETURN SHOULD BE LINKED TO THE REINSTALLATION OF RWANDA'S 350,000 WAR-DISPLACED. (NOTE . WE HAVE LEARNED THAT DEPUTY DIRECTOR FOR APRICA, ANDREW SOKIRI, WILL LEAD UNHCR'S DELEGATION TO ARUSH. END NOTE.)

14. A MEMBER OF THE GOR'S NEGOTIATING TEAM TOLD THE DCM THAT HE BELIEVES THE DISCUSSION AT ARUSHA WILL HAVE THREE ASPECTS. THE FIRST WOULD LIKELY INVOLVE A RESTATEMENT OF THE PRINCIPLES GOVERNING REPATRIATION AND THE OTHER REFUGEE OPTIONS ENVISIONED IN THE 1991 DAR ES SALAAM DECLARATION. THE SECOND WOULD FOCUS ON THE MODALITIES FOR IMPLEMENTING THE REFUGEE OPTIONS. THE THIRD WOULD ASSESS THE ASSISTACE, FROM BOTH

EVER SINCE THE RPF AGREED IN JUNE TO ACCEPT THE SINCERITY OF THE GOR COMMITMENT IN PRINCIPLE TO REFUGEE RETURN, THE REFUGEE ISSUE, THOUGH AT THE HEART OF THE SOLUTION, HAS BEEN MARGINAL TO THE PEACE TALKS. IN THE PROTOCOL ON THE RULE OF LAW SIGNED IN AUGUST, THE TWO SIDES ACKNOWLEDGED THE IMPORTANCE OF

16. WITH THE REFUGEE TALKS SCHEDULED TO FOLLOW  
COMPLETION OF TALKS ON POWER-SHARING AND MILITARY  
INTEGRATION, THE TIMEFRAME COULD EASILY SLIP, EVEN  
INTO THE NEW YEAR.

17. THE RWANDAN GOVERNMENT STRATEGY, IF CARRIED OUT  
AS OUTLINED BY MINISTER NDASINGWA, MAY OFFER THE  
BREAKTHROUGH NEEDED TO MOVE THE REGIONAL PROCESS  
AHEAD, EVEN IF IT MEANS DEVIATING FROM THE STRICTLY  
MULTI-LATERAL FRAMEWORK ENVISIONED IN THE 1991 DAR ES  
SALAAM DECLARATION ON RWANDAN REFUGEES. BY DELINKING  
THE THORNY, REGIONALLY SENSITIVE ISSUE OF  
NATURALIZING RWANDAN REFUGEES FROM THE MORE EASILY  
IMPLEMENTED OPTIONS OF REPATRIATION AND LOCAL  
SETTLEMENT, THE GOR MAY BE ABLE TO ENLIST THE SUPPORT

THE WAY TO DO THIS MIGHT BE TO SUPPORT AND PROMOTE WHAT WILL INEVITABLY BE UNHCR'S POSITION ON THIS ISSUE.

-- MAKE A COMMITMENT IN PRINCIPLE TO FINANCIAL ASSISTANCE FOR THE IMPLEMENTATION OF THE REPATRIATION PROCESS.
