I. GEN SITUATION. CALM AND UNCHANGED.

II. FACTIONAL ACTIVITIES.

A. POLITICAL. THE HEAD OF STATE RECEIVED SUBSEQUENTLY THE PRIME MINISTER AND THE PRIME MINISTER DESIGNATE. HE ANNOUNCED TO BE READY FOR THE INSTALLATION OF THE HETO WHEN THE POLITICAL PARTIES MOR AND PL WOULD HAVE RESOLVED THEIR INTERNAL PROBLEMS. HE ASYED TO ARRANGE A GOVERNMENT ASSEMBLY IN ORDER TO SHOW THE POPULATION THAT THE COUNTRY IS STILL GOVERNED. SREG MET THE PRIME MINISTER, THE PRIME MINISTER DESIGNATE AND THE MINISTER OF FOREIGN AFFAURS IN RESTAURANT HELENICK AT 19.00 ERS.
