#### SITREP COVERING PERIOD 220600B FEB TO 230600B FEB 94.

- 1. GEN SITUATION. OBSERVED TO BE EXPLOSIVE. THE SECURITY SITUATION: IN RWANDA AND IN PARTICULAR KIGALI CITY IS WORSENING. SEVERAL ROAD BLOCKS, SHOOTING INCIDENTS AND GRENADE EXPLOSINGS TOOK PLACE ALL OVER THE CITY THROUGH OUT THE DAY AND NIGHT. MANY CIVILIANS WITH INJURIES REPORTED TO UNAMIR FIELD HOSPITAL. ALL THE INJURED PERSONS WERE REPORTED TO BE BEATEN BY THE MEMBERS OF CDR AND MRND. FIVE DEATH CASE HAVE BEEN REPORTED SO FAR. OUT OF THEM ONE IS A RPF SOLDIER WHO SUSTAINED BULLET INJURY AND DIED LATER IN THE FIELD HOSPITAL. LOT OF BANDIT INCIDENTS TOOK PLACE IN VARIOUS PLACES IN THE TOWN. GENERAL PEOPLE ARE IN MORE PANIC. ON 221400 FEB 94 MR MARTIN BUCYANA, PRESIDENT OF CDR PARTY HAS BEEN KILLED AT A ROAD BLOCK AT A PLACE CALLED MBAJI APPROXIMATELY S KM NORTH OF BUTARE.
- 2. <u>POLITICAL ACTIVITIES</u>. A FRESH ATTEMPT AT SETTING UP BROAD BASED TRANSITIONAL GOVERNMENT AND THE TRANSITIONAL INSTITUTIONS HAVE BEEN PROGRAMMED FOR TODAY 23 FEB 94.

### 4. OWN MILITARY ACTIVITIES.

#### A. FORCE EQ. NTR.

THE UNOMUR OPERATIONAL AREA IS CALM. CA UNONUR. CAMPAIGNS STILL IN PROGRESS WITH NO SIGNIFICANT SIGNS OF VIOLENCE: KARIMAJONG REBELS 198UE REMAINS UNSOLVED. NRA KEEPING A LOW PROFILE IN OUR OPERATIONAL AREA RESPONSIBILITY. THEY ARE CONCENTRATING MORE EFFORTS ON THE REBBLS UP NORTH. THE HO STAFF FINALIZED THE AREA OPERATIONAL VISIT OF THE INCOMING A/CMO. ARRIVAL OF THE SAME IN KAMPALA CONFIRMED, BUT WILL BE PROCEEDING TO KABALE TODAY. AT SECTOR KABALE THE BOAT PATROL IS CANCELLED TODAY, DUE TO THE ILLNESS OF THE BOAT GUIDE. THE PATROLS HAVE SINCE BEEN TASKED WITH OTHER PATROL DUTIES. FROM 20 FEB 94 THE ICRC DELEGATION IN KAMPALA HAS BEEN INTEGRATED INTO THE REGIONAL DELEGATION OF THE INTERNATIONAL COMMITTEE OF THE RED CROSS BASED IN NAIROBI. A DELEGATE IN CHARGE REMAINED IN KAMPLA. CIVILIAN BORDER CROSSING AT GATUNA:

- SITUATION IN THE DMZ AREA REPORTED TO BE DNZ. REASONABLY CALM. AT ABOUT 1900 HRS THERE WAS A SHOOTING INCIDENT INVOLVING MILOB AND KIBATT ESCORTS AS WELL AS AN RPF ESCORT AT THE OUTSKIRTS OF KIGALI CITY. THE MILOBS AND KIBATT ESCORTS RETURNED TO THE DMZ AT 2130 HRS. TEAM A PROVIDED MEDIUM PTLS TO NKUMBA, KIDAHO, KINIGI AND RUHENGERI. TEAM B CARRIED OUT MEDIUM PTLS AT NYAMUTERA, GIEYE, KARAGO AND NYABIREHE. PROVIDED ESCORT TO BRITISH HIGH COMMISSIONER TO UGANDA FROM NGONDORE TO KIGALI. BYUBATT (GHANA BATTALION) CONDUCTED PTLS AT NYAKENE AND KABARE. PTL OBSERVED ABOUT 40 RPF TPS AT 023247 PREVIOUSLY REPORTED. CARRIED OUT MOBILE PTL WITHIN BETABLISHED AND MANNED A TEMP CHECK POINT AT KIDAHO. ALSO CARRIED OUT MOBILE PTLS TO BURGRANDI, KAWARNIRA AND NYARURAMBE: FORCE ENGINEER COY (BANGLADESH BATTALION) PROVIDED SY AT NGONDORE. PROVIDED ESCORT TO AICF FOR DITR OF FOOD AT GASIZA.
- MILOS. THE PERIOD MARKED BY KILLING, VIOLENCE. PROTESTS DEMONSTRATIONS AND INTIMIDATION BY FACTIONS OF DIFFERENT FOLITICAL PARTIES IN SEVERAL MAJOR CITIES. A NUMBER OF ROAD BLOCKS WERE PUT AROUND KIGALI WHICH CREATED BLOCKAGE OF TRAFFIC TO AND FROM KIGALI. THE LIFE PATTERN WAS DIGRUPTED AND MOST OF THE OFFICES. SHOPPING CENTERS. THE KILLING OF THE PRESIDENT OF COR PARTY AT BUTARE HAS FURTHER WORSENED THE SITUATION. DUE TO KILLING OF THE PRESIDENT OF THE CDR PARTY, SUPPORTERS OF SLAIN PSD POLITICAL LEADER CARRIED OUT DEMONSTRATION AND MOURNING PROCESSION IN BUTARE, THE SUPPORTERS OF PSD ALSO CREATED ROAD BLOCKS BY WOODS AND DAMAGED CAR ALL ALONG BUTARE TOWN. A MEETING WAS HELD BETWEEN THE POLITICAL, MILITARY AND LOCAL ELITES OF BUTARE ON THE DEVELOPMENT OF THE POLITICAL SITUATION.
  - FROM INFANTRY MILITARY. SMALL UNITS AND (1) GENDARMERIE WERE DEPLOYED ALONG THE MAIN STREETS AND SQUARE IN BUTARE TO PROVIDE SECURITY. BSTABLISHED 08 CHECK POINTS: THROUGH OUT THE KIGALI CONTROL/MONITOR THE SITUATION. CONDUCTED AN ESCORT FOR BRITISH HIGH COMMISSIONER FROM GATUNA CHECK POST TO KIGALI. ALSO ANOTHER ESCORT WAS SENT TO MULINDI TO ESCORT RPF PERSONNEL FROM MULINDI TO KIGALI. THE ESCORT COULD NOT REACH KIGALI DUE TO ROAD BLOCK NEAR GADDAFI JUNCTION POINT, AT THE OUT SKIRT OF KIGALI TOWN. THE ESCORT TEAM FALLEN SACK TO BYUMBA.

- E. KIGALI SECTOR. SEVERAL ROAD BLOCKS, DEMONSTRATIONS, SHOOTING, INCIDENTS, GRENADE EXPLOSIONS AND KILLING PROPLES PANICKED THE POPULATION OF KIGALI CITY THROUGH OUT THE DAY AND NIGHT. ON 222100 FBB 94 CNE RPF SOLDIER SUSTAINED BULLET INJURY LATER ON HE DIED, RPF PERSONNEL WITHOUT THE CONSENT OF UNAMIR LEFT CND TO RESCUE THE ESCORTS CAUGHT IN THE AMBUSH AND THEY EXCHANGED FIRE AT THE CROSSED ROAD OF GADDAPI POINT WITH OTHER UNIDENTIFIED ARMED MILITANT GROUP. SECTOR KIGALI CONDUCTED VEHICLE AND FOOT PATROL IN KIGALI CITY IN ORDER TO BNSURE KIGALI WEAPON SECURE AREA. PROVIDED 7 UNMO ESCORTS 3 FOR RPF, 2 FOR GENDARMERIE, 2 FOR RGF PERSONNEL. PROVIDED 4 ARMED ESCORTS 1 FOR PRIME MINISTER AND 1 FOR RPF PERSONNEL, 2 FOR UNAMIR. SECURED THE LOCATION OF THE RPF BATTALION IN KIGALI CITY, THE PRIME MINISTER'S OFFICE; FORCE HQ, SEC HQ AND KIGALI AIRPORT. FORCE HQ SECURITY WAS REINFORCED WITH ONE PLATOON DURING NIGHT. AS A PART OF SECURITY ARRANGEMENT FOR INSTALLATION OF BBTG. DURING THE NIGHT ASSURED PROTECTION OF THE PRIME MINISTER DESIGNATE, THE PRESIDENT OF THE CONSTITUTIONAL COURT, FIVE OPPOSITION MINISTERS AND SREG.
- 5. UNCIVIOL. THE SITUATION IS VERY TENSE BECAUSE OF THE INTENDED INSTALLATION OF BBTG AND THE MURDERING OF THE MINISTER OF PUBLIC WORK AND ENERGY AND THE PRESIDENT OF C.D.R PARTY IN BUTARE, CIVPOL INVESTIGATED IN THE CASE OF THE MURDERING OF THE MINISTER OF PUBLIC WORK AND ENERGY. SOME ROAD BLOCKS DURING THE DAY BECAUSE OF THE INTENDED INSTALLATION OF BBTG. CIVPOL WAS MONITORING THE SCHNE FROM 06.00 HRS TO 14.50 HRS AT THE DIFFERENT CHECK POINTS TOGETHER WITH MILOBS. ON 22 FEB 94 CIVPOL (PMT KIGALI) RECEIVED INFORMATION ABOUT THE KILLING OF MR KALINGANIRE JOSEPH. HE WAS MEMBER OF THE M.D.R. IT IS PRESUMED, THAT HE WAS MURDERED IN HIS HOUSE IN MBURABUTURO. CIVPOL 19 INVESTIGATING.
