I. GEN SITUATION. THE SITUATION REPORTED TO BE CALM AND UNCHANGED.

II. FACTIONAL ACTIVITIES.

A. POLITICAL. SRGS'S OFFICE HELD A MEETING ON 201030 DEC 93 WITH THE MINISTER OF COMMERCE AND PRESIDENT OF THE LIBERAL PARTY, ACCOMPANIED BY THE MINISTER OF JUSTICE AND VICE-PRESIDENT OF THE LIBERAL PARTY. NO DETAILS AVAILABLE SO FAR. A SECOND MEETING WAS HELD ON 201130 DEC 93 WITH THE PRIME MINISTER DESIGNATE AT THE PREMATURE. ON 201600 DEC SRSG MADE A COURTESY VISIT TO THE PRESIDENT OF THE PROTESTANT COUNCIL.

A. HQS. THE FUTURE LOCATION OF THE RPF BATTALION IN KIGALI CITY STILL BEING WORKED ON. FORCE HQ TOOK PREPARATIONS FOR THE RECONNAISSANCE BY RPF TO BE EXECUTED TODAY 21 DEC 93. PLANNING SEC HAD AN IMPORTANT MEETING WITH UNHCR AND UNDP ON THE ISSUE OF SECURITY, LONG TERM PLANNING AND DEMILITARIZATION. A REPORT WILL BE FORWARDED BY SEPARATE FAX.

  - (A) A MEETING WAS HELD AT NGONDORÉ (0529) WITH COMD SEC KIGALI AND RPF IN ORDER TO HAVE THE SOP KIGALI WEAPON SECURE AREA APPROVED. RGF DID NOT SHOW UP. RPF AGREED WITH THE ENGLISH VERSION AFTER SOME MINOR CHANGES BUT DID NOT AGREE WITH THE FRENCH VERSION. THIS ASPECT IS HOLDING UP IMPLEMENTATION OF KIGALI WEAPON SECURE AREA.
  - (B) CARRIED OUT PTL ON FOOT AND ON VEHICLE WITHIN OAR.
  - (C) RUTBAT IS FACING SERIOUS LOGISTIC PROBLEMS. HEALTH AND SANITATION BEING THREATENED DUE TO THE LACK OF WATER.
