1. CONFIDENTIAL - ENTIRE TEXT.

WE MAVE OBTAINED A COPY OF THE STATEMENT RELEASED BY THE MFA SPOKESHAN (I.E., FOREIGN SECRETARY) AT HIS PRESS CONFERENCE ON JULY 23 IMEPORTED REF A) ON THE PERVEZ HUCLEAR ARREST CASE. IT GIVES MUCH GREATER EMPHASIS TO THE CONSPIRACY EXPLANATION OF THE CASE THAN THE TEXT OF THE PROPOSED HEA STATEMENT PROVIDED TO THE AMBASSADOR BY THE FOREIGH MINISTER ON JULY 21 (REF B) AND THE STATEMENT RELEASED BY THE PAR EMBASSY TH WASHINGTON ON JULY 22 TREF CI. THE PAN EMBASSY STATEMENT AND THE PROPOSED NEA STATEMENT CLOSELY PARALLEL EACH OTHER IN CHARACTERIZING THE ATTEMPTED EXPORT AS THE "GUICOME OF A CONSPIRACY BY ELEMENTS WHO ARE OPPOSED TO THE CONTINUATION OF PARISTAN-U.S. RELATIONS AND HAVE BEEN ATTEMPTING TO DELIBERATELY SCUTTLE THE PASSAGE OF THE 1887-93 U.S. AID PACKAGE FOR PANESTAN." THE STATEMENT RELEASED BY MFA MAKES SEVERAL SHALL CHANGES AND INSERTS THE FOLLOWING ADDITIONAL SENTENCES: "WHAT STARTED AS A ROUT HE COMMERCIAL ENGULRY WAS, IN PURSUANCE OF THE CONSPIRACY, CONVERTED BY UNDER COVER AGENTS AND THEIR COLLABORATORS TO APPEAR AS AN 'UNHITIGATED CRIME' IN OUTRAGEOUS VIDLATION' OF U.S. LAWS. HOT ALL THE CONSPIRATORS AND THEIR COLLABORATORS HAVE YET BEEN IDENTIFEED BUT . . . "

3. FOLLOWING IS THE TEXT OF THE JULY 23 HEA STATEMENT WITH CHANGES FROM THE DRAFT STATEMENT GIVEN TO THE AMBASSAGOR ON JULY 21 IN PARENTHESES:

BEGIN TEXT: THE GOVERNMENT OF PARISTAN HAS
INSTITUTED AN IMMEDIATE HIGH LEVEL INVESTIGATION INTO
THE ALLEGED ATTEMPT BY A CANADIAN RESIDENT OF
PARISTANI ORIGIN TO EXPORT TO FARISTAN SPECIAL STELL
FROM THE UNITED STATES IN ALLEGED VIOLATION OF THE
RELEVANT LAUZ OF THE COUNTRY. -

ON THE BASIS OF THE INFORMATION SO FAR AVAILABLE, THE

CSO CALLED) ATTEMPT APPEARS TO BE THE OUTCOME OF A COMSPIRACY BY ELEMENTS MID ARE OPPOSED TO THE CONTINUATION OF SUPPORTIVE PARISTAN-US RELATIONS AND HAVE BEEN ATTEMPTING TO DELIBERATELY SCUTILE THE PASSAGE OF THE 1987-93 US AID PACKAGE FOR PARISTAN.
