1. *[initials]* HAS BEEN CHECKING SOME TIME ON RUMORS THAT BONA FIDE DRAFT OF EICHMANN MEMOIRES EXISTS. AFTER CONSIDERABLE CHECKING HAVE DETERMINED IT PROBABLE MEMOIRES ACTUALLY DO EXIST. PRIMARILY CONCERN EICHMANN'S ROLE DURING LAST WAR, PLACE MUCH OF BLAME ON OTHERS IN NAZI GERMANY INCLUDING NUMBER PERSONS WHO PRESENTLY ACTIVE FEDREP GOVERNMENT.

2. ACCORDING ALIAS *[initials]* HAS OBTAINED EVIDENCE DRAFT MEMOIRES CONTROLLED BY ONE FRIEHLER, FRIEND EICHMANN FAMILY, WHO INTERESTED SELLING MEMOIRES RAISE FUNDS FOR EICHMANN FAMILY. HE ENLISTED HELP ONE E. FRITSCH, NOW LIVING SALZBURG, FORMERLY RESIDENT ARGENTINA AND EDITOR NEO-NAZI NEWSPAPER "DER WEG" IN EFFORT FIND PUBLISHER MEMOIRES. ACCORDING *[initials]* INFO, FRITSCH HAS CONTRACT OF AGREEMENT WITH TIME-LIFE CALLING FOR THREE-INSTALLMENT PAYMENT \$15,000 FOR MEMOIRES. \$5,000 ALREADY PAID ALREADY AND REMAINDER TO BE PAID ONCE DETERMINED DRAFT MEMOIRES GENUINE. *[initials]* HAS ALSO HEARD FRITSCH NOW NEGOTIES CONTRACT WITH TIME-LIFE, HAS LEARNED SHOULD BE ABLE OBTAIN MINIMUM \$25,000 EUROPEAN PUBLISHER, AND NOW ATTEMPTING CANCEL TIME-LIFE CONTRACT AND REPAY \$5,000; SO BE ABLE NEGOTIATE MORE FAVORABLE
