Furthermore I also request all photographs of caskets containing the remains of U.S. military personnel at Dover A.F.B taken since Mr. Kick's December 2003 request to the present, all photographs of caskets containing the remains of U.S. military personnel received at any other U.S. military facilities between October 7, 2001 and the present.


Please note that the material sought by this particular FOIA request is intended to be utilized for educational teaching purposes in my classes here at the University of Delaware, and is not for my individual commercial use.
