


3. WE WOULD LIKE TO CLARIFY THE MOD'S ASSERTION THAT THE VETTING OF COLOMBIAN POLICE AND MILITARY CANDIDATES FOR U.S.-SPONSORED TRAINING HAS BEEN TAKEN OVER BY THE MINISTRY OF DEFENSE. WHILE WE WERE DELIGHTED TO SEE BOTERO GO ON RECORD THAT THIS IS THE AGREED UPON PROCEDURE (AND TAKE CREDIT FOR HAVING DEVISED IT), THE FACT IS THAT NO CONCRETE TRANSFER OF VETTING AUTHORITY HAS YET TAKEN PLACE. THE AMBASSADOR HAD VERBALLY PROPOSED THE IDEA TO BOTERO PRIOR TO HIS WASHINGTON TRIP, BUT HE DID NOT HAND THE LETTER FLESHING OUT THIS PROPOSAL UNTIL OCTOBER 12, AFTER BOTERO'S RETURN TO BOGOTA. AS OF OCTOBER 20 THE EMBASSY HAS RECEIVED NO WRITTEN REPLY, ALTHOUGH BOTERO TOLD THE AMBASSADOR THAT THE EMBASSY COULD DISCUSS THE DETAILS WITH HIS STAFF. IN LIGHT OF BOTERO'S COMMENTS, EMBASSY AND MLGRP OFFICIALS WILL NOW APPROACH WORKING CONTACTS IN BOTH THE MOD AND THE PROCURADURIA IN ORDER TO





HUMAN RIGHTS AND MILITARY PROMOTIONS

- 4. BOTERO STATED TO A/S SHATTUCK THAT "THERE IS A GROWING AWARENESS THAT COMMITTING HUMAN RIGHTS ABUSES WILL BLOCK AN OFFICER'S PATH TO PROMOTION." RECENT USDAO REPORTING (REF B) SUGGESTS THAT BOTERO'S CLAIM MAY BE SOMEWHAT UNFOUNDED AND REFLECT "WISHFUL THINKING" ON HIS AND THE ADMINISTRATION'S BEHALF. WHILE THERE IS NO EVIDENCE TO SUGGEST THAT SAMPER, BOTERO AND OTHER HIGH-LEVEL CIVILIAN OFFICIALS ARE NOT PERSONALLY COMMITTED TO IMPROVING THE ARMED FORCES' HUMAN RIGHTS PERFORMANCE AND ATTACKING IMPUNITY, THE SAME CANNOT BE SAID OF THE UNIFORMED LEADERSHIP OF THE MOD.
- 5. AS REPORTED IN REF B, THERE STILL EXIST STRONG INDICATORS TO SUGGEST THAT DESPITE THE GENERALS' LIP SERVICE TO THE PROGRESSIVE HUMAN RIGHTS POLICIES OF THE





SAMPER ADMINISTRATION, "BODY COUNT" MENTALITIES PERSIST, ESPECIALLY AMONG COLOMBIAN ARMY OFFICERS. FIELD COMMANDERS WHO CANNOT SHOW TRACK RECORDS OF AGGRESSIVE ANTI-GUERRILLA ACTIVITY (WHEREIN THE MAJORITY OF THE MILITARY'S HUMAN RIGHTS ABUSES OCCUR) DISADVANTAGE THEMSELVES AT PROMOTION TIME. THE SUCCESSFUL DERAILING OF SERIOUS MILITARY JUDICIAL REFORM BY A CLIQUE OF "OLD GUARD" GENERALS AND THE DISAPPOINTING RESULTS OF THE FORCED DISAPPEARANCE LEGISLATION ARE TWO EXAMPLES OF HOW, DESPITE BOTERO'S OPTIMISTIC CLAIMS, THE MILITARY HAS BEEN ABLE TO FORESTALL SERIOUS HUMAN RIGHTS PROGRESS ON THE



A/S SHATTUCK VISIT TO COLOMBIA

- 6. POST WAS PLEASED TO NOTE THE MOD'S INVITATION TO MR. SHATTUCK TO VISIT COLOMBIA AND CONSIDERS THAT A VISIT FROM THE DEPARTMENT'S SENIOR HUMAN RIGHTS OFFICIAL WOULD BE AN EXCELLENT WAY TO DEMONSTRATE TO THE GOC AND THE U.S. CONGRESS THE IMPORTANCE THE CLINTON ADMINISTRATION ACCORDS THE HUMAN RIGHTS ISSUE IN ITS BILATERAL RELATIONS WITH COLOMBIA. POST RECOMMENDS THAT SUCH A VISIT TAKE PLACE IN MID TO LATE JANUARY FOR SEVERAL REASONS.
- 7. FIRST, WE WANT TO GIVE THE SAMPER ADMINISTRATION A CHANCE TO UNVEIL ITS "PEACE PROCESS" PROPOSAL FOR THE 'GUERRILLAS, SLATED TO BECOME PUBLIC IN MID-NOVEMBER. THIS PLAN WILL HAVE OBVIOUS HUMAN RIGHTS POLICY IMPLICATIONS AND IT IS IMPORTANT THAT WE HAVE A CHANCE TO REVIEW IT THOROUGHLY. SECONDLY, BY JANUARY THE ADMINISTRATION SHOULD HAVE THE RECOMMENDATIONS OF THE TRUJILLO COMMISSION (REF C) AND A VISIT BY THE ASS'T SEC'Y AT THAT TIME COULD BE MOST USEFUL IN PRESSURING THE SAMPER ADMINISTRATION TO PROSECUTE THE MILITARY PERPETRATORS OF THOSE CRIMES.



PLAN OF ATTACK, HE HAS NONETHELESS BEEN ENGAGED IN THE ISSUE SINCE TAKING OFFICE. ALREADY HE HAS PUBLICLY TAKEN THE GENERALS TO TASK ON SEVERAL OCCASIONS FOR VOICING OPINIONS ON HUMAN RIGHTS ISSUES THAT ARE AT ODDS WITH ADMINISTRATION POLICIES. BOTERO IS QUITE AWARE OF THE FACT THAT THE INTERNATIONAL COMMUNITY IS LOOKING TO THE SAMPER ADMINISTRATION FOR CONCRETE PROGRESS ON HUMAN RIGHTS, SPECIFICALLY ON THE IMPUNITY QUESTION, AND THAT SIMPLY SAYING THE RIGHT THINGS WILL NO LONGER SUFFICE. JANUARY MEETING WILL AFFORD BOTH BOTERO AND SAMPER A REASONABLE TIME FRAME IN WHICH TO BEGIN TO EFFECT SOME OF THE MEETING WILL ALSO DOVETAIL NICELY WITH THESE CHANGES. THE PUBLICATION OF THE 1994 COLOMBIA COUNTRY REPORT WHICH SHOULD SERVE AS A USEFUL FOCUS OF DISCUSSION FOR THE ASS'T SECRETARY'S VISIT.
