SUMMARY .

1. (C) THE MAY 13TH FISCALIA/ARMY RAID AT THE BOGOTA OFFICE OF THE INTER-DENOMINATIONAL HUMAN RIGHTS GROUP, WHILE LARGELY CONDUCTED WITHIN THE TECHNICAL CONFINES OF THE LAW, WAS DESCRIBED AS A MAJOR BLUNDER BY SEARCH WARRANT WAS ISSUED BASED ON INFORMATION FROM THE ARMY THAT JUSTICIA Y PAZ'S COMPUTER FILES CONTAINED PROOF OF AN ELN PLOT TO ASSASSINATE FORMER DEFENSE MINISTER FERNANDO LANDAZABAL. THERE IS THE POSSIBILITY THAT THE RAID WAS RELATED TO LONG-STANDING FRICTION BETWEEN THE JESUIT DIRECTOR OF THE NGO AND THE COMMANDER OF THE ARMY'S 13TH BRIGADE. THE CONTROVERSY OVER THIS EVENT IS LIKELY TO GET WORSE. END SUMMARY.

BOGOTA 05554 01 OF 02 181220Z (U) REFTEL REPORTS THE MAY 13 FISCALIA/ARMY RAID AT THE BOGOTA OFFICE OF THE INTER-DENOMINATIONAL HUMAN RIGHTS GROUP, JUSTICIA Y PAZ, WHICH TOOK PLACE IN THE WAKE OF THE ASSASSINATION OF FORMER DEFENSE MINISTER FERNANDO LANDAZABAL. UN HUMAN RIGHTS

SOURCES SPEAKING FROM THE SCENE TOLD POLOFF VIA CELLULAR PHONE THAT "MINOR IRREGULARITIES" HAD TAKEN PLACE, BUT THAT THE RAID "WAS BEING DONE IN ACCORDANCE WITH THE LAW." THIS RAID WAS ONE OF AT LEAST 40 CONDUCTED IN CONJUNCTION WITH THE LANDAZABAL

INVESTIGATION.

(U) BOGOTA DAILIES AND THE UN HUMAN RIGHTS OFFICE REPORT THAT FISCALIA INVESTIGATORS ENTERED THE OFFICES OF JUSTICIA Y PAZ ACCOMPANIED BY 20 MEMBERS OF THE ARMY'S 13TH BRIGADE. THE AUTHORITIES ENTERED THE BUILDING AND MADE THOSE PRESENT KNEEL DOWN WHILE THE OFFICES WERE SEARCHED. (NOTE. THIS IS THE NORM DURING FISCALIA RAIDS. END NOTE.) HOWEVER, THERE ARE REPORTS THAT ARMY PERSONNEL HAD THEIR WEAPONS DRAWN UPON ENTERING THE BUILDING, AND CONTINUED TO BRANDISH THEIR GUNS DURING THE SEARCH. WHILE THERE, SOLDIERS READ CASE FILES (SOME OF WHICH MAY HAVE BEEN RELATED TO HUMAN RIGHTS COMPLAINTS AGAINST PUBLIC SECURITY FORCES), SEARCHED COMPUTER RECORDS, TOOK PHOTOS AND VIDEOTAPED PEOPLE INSIDE AND AROUND THE BUILDING. INITIAL REPORTS INDICATING THAT THE NGO MINGA HAD ALSO BEEN RAIDED WERE INCORRECT (REFTEL).

Y PAZ. THE INVESTIGATOR IN CHARGE CALLED OFF THE SEARCH WHEN IT
BECAME CLEAR THAT THEY WERE AT AN NGO, AND THAT THE ARMY'S
ALLEGATIONS THAT THE GROUP'S COMPUTER FILES CONTAINED PROOF OF AN
ELN ASSASSINATION PLOT WERE UNFOUNDED.

- 5. (U) ON THE EVENING OF MAY 13, VICE-FISCAL JAIME CORDOBA WENT ON THE RADIO TO CRITICIZE THE ARMY, EMPHASIZING THAT THE FISCALIA HAD NO IDEA THAT THE ADDRESS THEY HAD BEEN GIVEN WAS A LEGITIMATE NGO. BY THE MORNING OF THE 14TH, CORDOBA'S STATEMENTS WERE MORE MEASURED, SAYING THAT THE RAID WAS NOT A MISTAKE, AND THAT NGOS ARE NOT "ABOVE THE LAW." HE ADDED, HOWEVER, THAT "NGOS ARE ENTITIES THAT MERIT THE SUPPORT OF THE STATE."
- 6. (U) IN ANOTHER LANDAZABAL RELATED DEVELOPMENT, AUTHORITIES ARRESTED AN UNIDENTIFIED MAN TRAVELLING IN A CAR ALLEGEDLY MATCHING WITNESSES' DESCRIPTION OF THE VEHICLE IN WHICH THE ASSASSINS ESCAPED THE SCENE OF LANDAZABAL'S MURDER. HOWEVER, WITNESS REPORTS DIFFER WIDELY AS TO THE PARTICULARS OF THE CAR USED IN THE CRIME, AND IT IS UNCLEAR WHETHER THE MAN WILL BE HELD.


