(U) AT AN OCTOBER 6 HEARING IN WASHINGTON, THE INTERAMERICAN COMMISSION ON HUMAN RIGHTS REQUESTED THAT THE DOMINICAN GOVERNMENT APPOINT THREE MEMBERS TO A SIX MEMBER OVERSIGHT COMMISSION. THE NEW BODY, TO INCLUDE THREE MEMBERS OF THE NON-GOVERNMENTAL TRUTH COMMISSION, WOULD PROVIDE GUIDANCE TO THE INVESTIGATING JUDGE EXAMINING THE 1994 DISAPPEARANCE OF UNIVERSITY PROFESSOR NARCISO GONZALEZ. DOMINICAN GOVERNMENT REPRESENTATIVES HAVE ASKED FOR THIRTY DAYS TO DECIDE WHETHER TO AGREE TO PARTICIPATE ON THE PROPOSED COMMISSION. TRUTH COMMISSION PRESIDENT TOMAS CASTRO TOLD US THIS WEEK HE HAD HOPED FOR A LARGER OVERSIGHT BODY, BUT HE EXPECTS THE NEW COMMISSION TO PLAY A PROACTIVE ROLE.

MOVEMENT ON WASHINGTON PROTOCOL AND OTHER TREATIES?

(SBU) DOMINICAN DAILY OF RECORD LISTIN DIARIO GAVE FRONT PAGE COVERAGE TO THE NATIONAL CONGRESS'S FAILURE TO RATIFY A NUMBER OF INTERNATIONAL AGREEMENTS SIGNED OVER THE YEARS BY THE DOMINICAN EXECUTIVE. SIGNED BUT UNRATIFIED AGREEMENTS INCLUDE THE WASHINGTON PROTOCOL. THE MANAGUA PROTOCOL, THE INTERAMERICAN CONVENTION AGAINST CORRUPTION, THE LAW OF THE SEA, AND THE CONVENTION ON MISSING PERSONS, AMONG OTHERS. THE ARTICLE DID NOT MENTION THE EXECUTIVE'S FAILURE -- OVER A PERIOD OF DECADES -- TO REFER MOST OF THESE AGREEMENTS TO CONGRESS AFTER SIGNING THEM. FRENCH EMBASSY COUNSELLOR ERIC LAVERTU TOLD US THE DNCD EVENTUALLY RELEASED THE FRENCHMEN, THAT THEY DO NOT ALLEGE ANY FORM OF TORTURE, AND THAT DOMINICAN AUTHORITIES WILL NOT FILE CHARGES AGAINST THEM. LAVERTU SAID HE HAD SOUGHT TO KEEP THE MATTER OUT OF THE PRESS. BUT -- HE BELIEVES -- THE PROSECUTOR'S OFFICE LEAKED THE STORY AS PART OF AN ONGOING CAMPAIGN TO EMBARRASS THE DNCD AND FOLCH. DOMINICAN NEWSWEEKLY RUMBO HAS ALLEGED THAT FOLCH SOUGHT TO SEIZE THE BEACH HOUSE OF ONE OF THE FRENCHMEN IN PALMAR DE OCOA.
