2. (S) THE INVESTIGATIVE COMMISSION IS NOW SCHEDULED TO SUBMIT ITS FINAL REPORT TO THE JUNTA CENTRAL ELECTORAL (JCE) ON JULY 12. ONE COMMISSION MEMBER IS STRIVING TO HAVE THE REPORT MENTION FRAUD. WE REMAIN CONVINCED THAT THE MOST LIKELY SCENARIO IS THE PROCLAMATION OF BALAGUER AS THE VICTOR. THIS COULD OCCUR BETWEEN JULY 15-20. THE NEXT MOST PLAUSIBLE SCENARIO INVOLVES NEW ELECTIONS, EITHER PARTIAL OR GENERAL. THE DOMINICAN REVOLUTIONARY PARTY (PRD) IS

3. (S) LEFTIST GROUPS HAVE BEGUN A CAMPAIGN OF STREET PROTESTS AND THE GODR IS REPORTEDLY DETAINING PRD ACTIVISTS. THE PRD HAS NOW EXPRESSED SYMPATHY FOR THE PROTEST CAMPAIGN AND WILL LIKELY JOIN THE PROTESTS IF BALAGUER IS PROCLAIMED THE WINNER OR THE POLITICAL PARTY ALLIANCES ANNULLED. WE EXPECT A JCE JUDGE TO INTIATE A CAMPAIGN TO DISCREDIT USG-FUNDED INTERNATIONAL ADVISORS.

4. (C) WE HAVE THE FOLLOWING TENTATIVE CONCLUSIONS ABOUT THE DOMINICAN ELECTIONS: A) FRAUD TOOK PLACE, B) CURRENT NUMBERS ON DISENFRANCHISED VOTERS CAN NOT BE CONSIDERED DEFINITIVE, C) THE INVESTIGATIVE COMMISSION AND ITS FINAL REPORT WILL HAVE CREDIBILITY PROBLEMS, D) THE OAS AMBASSADOR IS INCLINED TO ENDORSE THE COMMISSION'S WORK, E) THE GOVERNING PARTY BELIEVES THAT THE USG IS BLUFFING ON THE ELECTION ISSUE, AND, F) THE SCENARIO OF NEW ELECTIONS REMAINS THE BEST OPTION. CURRENT DEVELOPMENTS

5. (C) THE LATEST WORD (AS OF THE MORNING OF JULY 11) IS THAT THE INVESTIGATIVE COMMISSION IS STRIVING TO TURN OVER ITS FINAL REPORT TO THE JCE ON TUESDAY, JULY 12; WE BELIEVE IT COULD STILL SLIP TO A LATER DATE. CIVILITY PACT REPRESENTATIVE HAS TOLD US THAT HE IS ATTEMPTING TO ENSURE THAT THE REPORT MENTIONS THE PROBABILITY THAT FRAUD OCCURRED.

DOES NOT SHARE HIS PREOCCUPATION AND IS LESS INCLINED TO SIGN A STATEMENT SAYING THAT MANIPULATION TOOK PLACE. INTERNATIONAL FOUNDATION FOR ELECTORAL SYSTEMS (IFES) EXPERT JORGE TIRADO HAS YET TO FINISH HIS REPORT TO THE COMMISSION ALTHOUGH IT HAS BEEN DISCUSSED BY COMMISSION MEMBERS. TIRADO WILL NOT CONCLUDE ONE WAY OR THE OTHER THAT FRAUD/MANIPULATION OF THE VOTERS LISTS TOOK PLACE. HE HAS NOT BEEN ABLE TO ESTABLISH CONCRETE PROOF THAT IT DID TAKE PLACE. WITHOUT SOLID PROOF HIS REPORT WILL NOT BE CONCLUSIVE AND HE WILL RECOMMEND FURTHER

INVESTIGATION.

6. (S) WE CONTINUE TO BELIEVE THAT A JCE PROCLAMATION OF BALAGUER AS THE WINNER IS THE MOST LIKELY SCENARIO. SOCIAL CHRISTIAN REFORMIST PARTY (PRSC) LEADERS SUCH AS JACINTO PEYNADO ARE HARDENING THEIR RHETORIC AND ARE DEMANDING THAT THE JCE DECLARE BALAGUER THE WINNER; WE ARE NOW HEARING THAT THIS MAY OCCUR DURING THE JULY 15-SECRET

7. (C) ELECTIONS, EITHER PARTIAL OR GENERAL, IS THE MOST PLAUSIBLE OF THE REMAINING SCENARIOS. THE VISIT OF PDAS SKOL (SEPTEL) HAS LENT CREDIBILITY TO THIS OPTION. PENA GOMEZ AND THE PRD ARE NOW ADVOCATING COMPLETELY NEW ELECTIONS. THERE REMAINS A WIDESPREAD FEAR OF A PROVISIONAL GOVERNMENT BUT MANY ARE NOW BEGINNING TO CONFRONT THE ISSUE.

8. (S) LEFTIST FRINGE GROUPS SUCH AS THE COLLECTIVE OF POPULAR ORGANIZATIONS (COP) HAVE BEGUN TO EMBARK ON A CAMPAIGN OF SOMETIMES VIOLENT STREET PROTESTS (SEPTEL) AGAINST ELECTORAL FRAUD AND THE DISAPPEARANCE OF NATIONAL UNIVERSITY (UASD) PROFESSOR NARCISO GONZALEZ. ON JULY 9, THE NATIONAL POLICE ARRESTED FOUR PRD AND ONE UD (PRD ALLY) ACTIVISTS, PRESUMABLY IN A PREEMPTIVE MOVE AGAINST SCHEDULED JULY 11 PROTESTS IN NORTHERN SANTO DOMINGO. WE HAVE JUST RECEIVED ANOTHER REPORT OF WEEKEND DETENTIONS OF AT LEAST 10 PRD ACTIVISTS IN SANTO DOMINGO, LA ROMANA, AND NAGUA. WHILE THE PRD HAS YET TO OFFICIALLY JOIN THE STREET PROTESTS, A JULY 10 HIGH-LEVEL PRD MEETING RESULTED IN

9. (S) SECURITY SERVICES ACTIONS AGAINST PRD ACTIVISTS MAY GOAD THE PRD INTO FORMALLY JOINING THE PROTESTS. THE PRD LEADERSHIP IS REPORTEDLY FACING STRONG PRESSURE FROM ITS BASES TO TAKE TO THE STREETS. SECRET

WE DO NOT FORESEE THE DOMINICAN SECURITY SERVICES TAKING NOTE OF SUCH DISTINCTIONS IN THEIR REACTIONS TO STREET PROTESTS.

10. (S) WE UNDERSTAND THAT JCE JUDGE MATOS BERRIDO IS DEVELOPING INFORMATION WITH THE AIM OF DISCREDITING USAID-FUNDED IFES ADVISORS. THIS ACTION IS AN APPARENT REACTION TO A READING OF THE DRAFT REPORT BY IFES ADVISOR CARINA PERELLI, A COPY OF WHICH HE OBTAINED FROM SOMEONE IN THE JCE. DURING THE PDAS SKOL VISIT, MATOS EXPRESSED THANKS FOR THE WORK OF U.S.-FUNDED ADVISORS IN ALL AREAS OF JCE ACTIVITIES. WE SUSPECT THAT MATOS AND THE PRSC WILL NOW ATTEMPT TO BLAME THE ADVISORS FOR THE ELECTION PROBLEMS. (NOTE: THE IFES REPORTS DETAIL HOW ADVICE WAS OFFERED TO, AND REPEATEDLY REJECTED BY, THE JCE.)

TENTATIVE CONCLUSIONS ABOUT THE DOMINICAN ELECTIONS

11. (C) BEARING IN MIND THE SCHEDULED HFAC WESTERN HEMISPHERE SUBCOMMITTEE HEARINGS ON JULY 13, THE FOLLOWING ARE TENTATIVE EMBASSY CONCLUSIONS ABOUT THE ELECTIONS BASED ON WHAT WE KNOW AS OF JULY 11.

12. (S) CONCLUSION A: WE ARE CONVINCED THAT FRAUD SECRET

TAKEN INDIVIDUALLY, THERE EXISTS THE POSSIBILITY (HOWEVER SMALL) THAT EACH TYPE OF IRREGULARITY COULD BE EXPLAINED AWAY DUE TO ERROR OR INCOMPETENCE. HOWEVER, IT WOULD TAKE AN UNBELIEVABLE CHAIN OF CIRCUMSTANCES TO EXPLAIN AWAY ALL OF THE VARIOUS IRREGULARITIES IN THE ELECTIONS.

13. (C) CONCLUSION B: THE CURRENT FIGURES (26-38 THOUSAND) OF DISENFRANCHISED VOTERS CAN NOT BE CONSIDERED AS AUTHORITATIVE AND DEFINITIVE ESTIMATES ALTHOUGH THEY WILL LIKELY BE PRESENTED AS SUCH IN THE INVESTIGATIVE COMMISSION'S FINAL REPORT. ARE ON SHAKY GROUNDS WHEN THEY CONTEND THAT THE PRD HAS EXHAUSTED ITS REVIEW OF ELECTORAL LISTS, AN ASSERTION DENIED BY THE PRD. REJECTS THE PRD CLAIM BECAUSE HE BELIEVES THAT HE RECEIVED THE TRUE PICTURE FROM ONE PRD TECHNICIAN. IN EFFECT, HE IS BASING HIS JUDGEMENT ON THE WORD OF ONE PERSON UNSUBSTANTIATED BY ANY OTHER

14. (C) CONCLUSION C: THE INVESTIGATIVE COMMISSION'S RESTRICTED MANDATE, LIMITED TIME, AND RELIANCE ON THE JCE COMPUTER CENTER WILL RAISE SERIOUS CONCERNS ABOUT ITS CREDIBILITY. THE COMMISSION'S MANDATE IS NOT TO INVESTIGATE, BUT RATHER TO VERIFY PROOF OF IRREGULARITIES PRESENTED BY THE POLITICAL PARTIES, THEREBY LEAVING ITSELF OPEN TO CRITICISM AS

THE JCE WOULD NOT ORDER THE MUNICIPAL ELECTORAL BOARDS TO TURN OVER COPIES OF EACH ELECTORAL TABLE VOTER LIST. THUS, THE COMMISSION WAS FORCED TO RELY ON A SAMPLING OF THE FIRST, SECOND, AND LAST TABLES IN EACH MUNICIPALITY. (NOTE: THE COMMISSION FOUND 45 OF THE 107 MUNICIPALITIES TO HAVE PROBLEMS WITH DISENFRANCHISED VOTERS, AN INDICATION OF WIDESPREAD IRREGULARITIES.) IN ADDITION, THE PRD CHARGES OF MULTIPLE VOTING AND VOTING BY THE MILITARY HAVE NOT BEEN THOROUGHLY REVIEWED BY THE COMMISSION. THE COMMISSION IS DEDICATED TO COMING OUT WITH A SOLID REPORT BUT IS HAMPERED BY THE LIMITS OF ITS TIME AND RESOURCES. UNFORTUNATELY, THE COMMISSION'S REPORT TO THE JCE WILL BE TREATED AS THE DEFINITIVE RESPONSE TO CHARGES OF FRAUD AND OTHER IRREGULARITIES; WE DO NOT BELIEVE THAT THE REPORT MERITS SUCH A DESIGNATION.

15. (C) CONCLUSION D: OAS AMBASSADOR GRAHAM WILL ATTEMPT TO ENDORSE THE COMMISSION REPORT. BASED ON EXTENSIVE CONVERSATIONS WITH GRAHAM, WE BELIEVE THAT GRAHAM'S HIGHEST PRIORITY IS TO AVOID VIOLENCE OR

17. (C) CONCLUSION F: THE NEW ELECTIONS SCENARIO REMAINS THE BEST OF A SERIES OF UNAPPEALING OPTIONS. THE TIME AND COST OF NEW ELECTIONS, AND THE CONSEQUENT UNKNOWN OF A PROVISIONAL GOVERNMENT, ARE THE OBVIOUS DRAWBACKS TO THIS OPTION BUT WE SEE NO OTHER PALATABLE ALTERNATIVE.
