

| SUBJECT | Meeting with Mr. Kermit Roosevelt |

1. On 23 February I met with Mr. Kermit Roosevelt and his son, Jonathan Roosevelt, to discuss the comments you submitted in your memorandum to me of 14 February 1977. Mr. Roosevelt was most willing to cooperate and explained that the publisher of his manuscript, the Reader's Digest Publishing Company, had gone out of business and therefore at this time he does not have a publisher. Mr. Roosevelt said that his trip to Iran has been postponed because the particular minister that he was to visit is suffering from leukemia and is recuperating in southern France.
