RWANDAN HUMAN RIGHTS ACTIVIST MONIOUE MUJAWAMARIYA. IN WASHINGTON FOR MEETINGS ARRANGED BY AFRICA WATCH WITH DEPARTMENT (HA AND AF), NSC AND SENATORS KENNEDY AND SIMON, WAS THREATENED AFTERNOON OF APRIL 21 AS SHE LEFT A BRIEFING AT THE U.S. COMMITTEE FOR REFUGEES OFFICE. PERSON IN A GROUP OF RWANDANS WAITING OUTSIDE WHEN THE MEETING ENDED MADE A DIRECT THREAT AGAINST MS. MUJAWAMARIYA'S CHILDREN, WHO ARE IN HIDING IN RWANDA. THE GROUP INCLUDED RWANDAN EMBASSY STAFF AND SPOUSES, BUT IT IS NOT CLEAR WHETHER THE PERSON WHO MADE THE THREAT WAS AFFILIATED WITH THE EMBASSSY. WHEN SENATOR KENNEDY CALLED AMBASSADOR UWIMANA LATE AFTERNOON APRIL 21 TO EXPRESS HIS OUTRAGE OVER THE THREAT, THE SENATOR REPORTED THAT AMB. UWIMANA HIMSELF MADE FURTHER THREATENING STATEMENTS ABOUT MS. MUJAWAMARIYA'S CHILDREN. (COMMENT: SINCE NEITHER KENNEDY NOR UWIMANA SPEAKS THE OTHER'S LANGUAGE. THERE MAY HAVE BEEN A MISCOMMUNICATION. END COMMENT.)

- 4. DEPARTMENT CONVOKED RWANDAN AMBASSADOR ALOYS UWIMANA MORNING OF APRIL 22 TO EXPRESS OUTRAGE AT THE THREAT AGAINST MS. MUJAWAMARIYA. AF DAS PRUDENCE BUSHNELL TOLD AMBASSADOR UWIMANA THAT IF IT IS TRUE THAT THE THREAT WAS ISSUED BY SOMEONE FROM THE RWANDAN EMBASSY, THIS BEHAVIOR IS COMPLETELY UNACCEPTABLE. AMBASSADOR UWIMANA, VISIBLY UPSET AND ANGRY, TRIED TO DIVERT THE DISCUSSION OFF ON AN IRRELEVANT TANGENT, AND MADE REFERENCE TO MS. MUJAWAMARIYA'S COMPORTMENT AND RELATIONSHIP WITH HER EX-HUSBAND, WHOM HE ALLEGED WAS A MEMBER OF THE RWANDAN MILITARY. DAS BUSHNELL STERNLY REMINDED AMB. UWIMANA THAT THE ISSUE AT HAND WAS THE UNACCEPTABLE BEHAVIOR OF THOSE MAKING THREATS AGAINST MS. MUJAWAMARIYA HERE IN THE UNITED STATES.
- 5. DAS BUSHNELL SAID THAT MS. MUJAWAMARIYA HAD TOLD HER THAT THE PERSON WHO MADE THE THREAT WAS AFFILIATED WITH THE RWANDAN EMBASSY. DAS BUSHNELL WENT ON TO REITERATE THAT NO MATTER WHO UTTERED THE THREAT, THE IMPRESSION HELD BY THE DEPARTMENT AND BY SEVERAL KEY SENATORS WAS THAT THE THREAT CAME DIRECTLY FROM THE RWANDAN EMBASSY, AND THAT THIS TYPE OF BEHAVIOR GIVES SENATORS, THE WHITE HOUSE AND THE NSC A VERY BAD IMPRESSION OF RWANDA. SHE URGED THE AMBASSADOR TO INVESTIGATE WHO HAD ISSUED THE THREAT, AND TO TAKE RESPONSIBILITY IF IT WAS AN EMBASSY
