OUR CONCERNS ARE NOT RPT NOT ALLAYED BY GUTIERREZ' SOPORIFIC ASSURANCES THAT THE GOCR/GRN AGREEMENT IS "QUITE A WAYS OFF" THE FACT OF THE MATTER IS THAT THEY ARE NEGOTIATING ON A QUESTION WITH CRITICAL IMPLICATIONS FOR FRIENDS IN THE REGION. MOREOVER, AGREEMENT APPEARS TO HAVE ALREADY BEEN REACHED ON THE PRINCIPLE OF A BILATERALLY NEGOTIATED DMZ.
